**A RESOLUTION OF THE BOROUGH OF NORTH CATASAUQUA, COUNTY OF  
NORTHAMPTON, COMMONWEALTH OF PENNSYLVANIA, ADOPTING THE  
RIVER CENTRAL MULTI-MUNICIPAL COMPREHENSIVE PLAN**

WHEREAS, pursuant to Section 1202(24) of the Borough Code, at 8 Pa. C.S.A. § 101 et seq., authorizing the Borough to enter into agreements with other political subdivisions, the Intergovernmental Cooperation Law, at 53 Pa. C.S.A. § 2301, et seq., provides that two or more Municipalities may jointly cooperate in the exercise or in the performance of their respective governmental functions, powers and duties and the Pennsylvania Municipalities Planning Code at 53 P.S. § 10101 et seq., the Borough of North Catasauqua, by and through their Borough Council, together with the Township of East Allen, the Township of Hanover, the Borough of Catasauqua, and the Borough of Northampton (collectively “the Parties”) with consulting services provided by the Lehigh Valley Planning Commission, participated in the preparation of a Multi-Municipal Comprehensive Plan (“the Plan”); and

WHEREAS, the Plan consists of maps, charts and textual material required by Article III, §§ 10301, 10301.1 and 10301.2 of the Pennsylvania Municipalities Planning Code; Borough of North Catasauqua adopted the Intermunicipal Agreement on October 7, 2019, by the passage of Ordinance 421; and

WHEREAS, with the assistance of the Lehigh Valley Planning Commission, the Borough of North Catasauqua has compliant with all of the notice, hearing, and public comment requirements dictated by Article III, §§ 10301.2 and 10302 of the Pennsylvania Municipal Planning Code; and


WHEREAS, the Borough Council of the Borough of North Catasauqua finds that the Plan adequately addresses matters concerning land use and development within its jurisdiction;

That the River Central Multi-Municipal Comprehensive Plan, attached hereto as “Exhibit A,” is hereby adopted as the Comprehensive Plan for the Borough of North Catasauqua, Northampton County, Pennsylvania.


